Property Owner/Occupant

A petition to allow your Recreational Vehicle to be parked upon a public street in front of a lot owned/controlled by you, within the Town of Mills. The petition has five lots on it. You must obtain the signatures of four of the five lots adjacent to and across the street from the applicant, agreeing to the parking of such recreational vehicle. The five lots shall mean the two lots immediately adjacent on the same side of the street (one on each side) and the three lots immediately across the street.

For your neighbors to agree, have them print their name, sign and date, and list a good contact phone number upon the petition. Once you have the approval of your neighbors on the petition, turn the petition in to the Mills Town Hall at 704 4th St. There is a \$25.00 dollar fee for this permit and it is no-refundable.

The Town of Mills will verify the agreement, by phone, of the signatures. The Chief of Police has the final say in approving the permit. The Chief of Police can deny said permit for any reason, such as but not limited to: being on Arterial Street, a collector street, insufficient access to adjacent properties, sufficient room on applicant's property for storage of the recreational vehicle.

Once the Chief of Police approves or denies the permit a letter will be given to the applicant explaining that it was approved or denied. If it was approved it will contain a permit for the recreational vehicle. The permit must be placed on your recreational vehicle in a conspicuous spot. If the permit is denied then you will have five days to remove the recreational vehicle or it will be towed and stored at your expense.

The permit is good for one: five month consecutive period in a calendar year, and the entire process must be repeated every year. The permit is not transferrable.
