

ORDINANCE NO. 189

AN ORDINANCE TO AMEND AND RE-ENACT  
ORDINANCE NO. 111, SECTION 4, APPEARING  
IN THE MILLS MUNICIPAL CODE AS SECTION  
12.04.040, ENTITLED "COMPLETION".

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF  
MILLS, WYOMING

SECTION 1. COMPLETION AND PAYMENT OF COSTS. All work  
requiring a hole, cut or fill shall be completed and filled the same calendar  
day to the satisfaction of the Street Commissioner, unless additional time  
is requested and approved by the Street Commissioner; said additional time  
shall not be unreasonably denied; by the person, firm or corporation, prop-  
erty owner, utility or public utility board making the cut, and the earth shall  
be thoroughly and solidly tamped and settled.

The pavement or surfacing shall be replaced and patched by the Town  
of Mills with material equal to the former surface at a cost of \$1.00 per square  
foot. Said costs shall be paid to the Town of Mills by the person, firm or  
corporation, property owner, utility or public utility board responsible for  
making the cut.

SECTION 2. FORMER ORDINANCE REPEALED. Section 4 of  
Ordinance 111, and any and all ordinances or parts of ordinances in conflict  
herewith are hereby repealed.


