ORDINANCE NO. 190

AN ORDINANCE TO AMEND AND RE-ENACT ORDINANCE NO. 99, SECTION 3, APPEARING IN THE MILLS MUNICIPAL CODE AS SECTION 13.08.030, ENTITLED "RESPONSIBILITY OF UNINTERRUPTED SERVICE".

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING.

SECTION 1. The Town shall only be responsible, and it is hereby made the duty of the Town and of the officers thereof, to make all reasonable effort to furnish continuous and uninterrupted main line sewage service to each and every user having a legal right to hook-on or attach to the main line. This section shall not apply to any user who has, by reason of non-payment of charges assessed against him, or by violation of any provision of this chapter or of any related ordinance, forfeited his right to the service. The Town shall not be liable to any suit for damage or other claim against the Town arising from, or based upon, any unavoidable interruption of the main line sewage service, but shall make every reasonable effort to restore the serviceas soon as possible. It shall be unlawful for any officer of the Town to make, permit, or allow to be made, any hook-on attachment to the main line sewer system or to any line thereof, beyond the number of attachments that the sewer is estimated to properly and adequately accommodate. For the purposes of this provision, the decision shall rest with the Mayor and Council, subject to reference to competent state authority.

SECTION 2. FORMER ORDINANCE REPEALED. Section 3 of Ordinance 99, and any and all ordinances or parts of ordinances in conflict herewith are hereby repealed.
