

ORDINANCE NO. 193

AN ORDINANCE TO AMEND AND RE-ENACT ORDINANCE NO. 99, SECTION 1, APPEARING IN THE MILLS MUNICIPAL CODE AS SECTION 13.08.010, ENTITLED "DEFINITIONS".

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING.

SECTION 1. As employed in this chapter, for the purpose of this chapter, and excepting those cases in which a different meaning is clearly indicated by the context, the terms defined in this section shall have the meaning and application established, and shall not be otherwise construed:

- (1) "Person" means and includes any natural person, family, organization, corporation, business firm, or any other group of persons who may lawfully act as a unit in the matter of purchasing sewerage service from the town;
- (2) "User" means any person as defined in subsection (1), residing in, or operating from, one location from which sewage service is purchased by the person from the town. In the case of any person operating or conducting a business, or businesses, at two or more separate establishments, the person shall for the purposes of this chapter be deemed a user in each of the separate establishments, and charges for the service furnished by the town from each of the separate establishments shall be imposed against the person, the same as though such person were actually two separate users. No group of persons or group of families occupying the several and separate units of any apartment house, tourist or cabin camp, trailer court, or other multiple dwelling establishment, shall act as a unit in the matter of purchasing sewage service from the town for the purpose of being deemed one single user of the service, nor shall the owner of any multiple

dwelling establishment be eligible to purchase sewage service for more than one unit of the establishment under the terms hereinafter established for one single user, but nothing herein shall be construed as prohibiting the owner from purchasing from the town sewage service for the establishment, or any part thereof, as provided in Section 13.08.120;

(3) "Mills", "town of Mills," and "the town" mean and refer to the town of Mills, Wyoming, and none other;

(4) "Sewer," "sewer system," "sewer line," "main line," "sewer main," and "disposal plant" mean the Mills sewer system or the designated part thereof, and any named part of a sewer line, and any named appurtenance to a sewer line, means such part of, or such appurtenance to, the Mills sewer line or system, or to a line or part thereof; main sewer line means the central collecting sewer pipe as distinguished from the individual sewer lines which service the individual users and includes any "Y" joints or saddle joints attached directly to or a part of the main sewer line.

(5) "Sewer commissioner," means the Mills sewer commissioner, and unless otherwise specifically stated, any other officer mentioned herein shall be understood to be such officer of the town;

(6) Any street, alley, or other location mentioned herein shall be understood to be within the town, and no such reference shall be otherwise construed;

(7) "Ordinance," "town ordinance," and "law" unless otherwise indicated by the context, mean this chapter and if not this chapter, the legally enacted ordinances of the town generally, or the specified one of such ordinances. (Ord. 99 Sec. 1, 1953).

SECTION 2. FORMER ORDINANCE REPEALED. Section 1 of Ordinance 99, and any and all ordinances or parts of ordinances in conflict herewith are hereby repealed.
