

ORDINANCE NO. 194

AN ORDINANCE DEFINING FIRE LANES; DESIGNATING CERTAIN ALLEYS AS FIRE LANES; RESTRICTING PARKING THEREIN; AND PROVIDING PENALTIES FOR THE VIOLATION OF THE ORDINANCE.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING.

SECTION 1. DEFINITIONS. The term "fire lane" as used in this ordinance shall mean an alley or alleys within which the parking of vehicles is prohibited in order to insure safe access by fire fighting equipment and other emergency vehicles. The term "park" when prohibited in a fire lane, as provided in this ordinance, means the standing of a vehicle, whether occupied or not, otherwise than temporarily for the purpose of and while actually engaged in loading or unloading said vehicle.

SECTION 2. PARKING RESTRICTED IN FIRE LANES. No person shall park a motor vehicle or motor vehicles in a fire lane as designated by ordinance and where official signs prohibit parking or declare the area to be a fire lane.

SECTION 3. The alleys which run generally in a northerly and southerly direction in Blocks 15, 16, and 18 between Wasatch and Midwest Streets of the Town of Mills, Wyoming, are declared to be fire lanes.

SECTION 4. PENALTY. Upon conviction of having parked in a fire lane, the person convicted shall be fined not less than \$1.00 nor more than \$100.00.

SECTION 5. SAVINGS CLAUSE. If any section, sub-section, sentence or clause of this ordinance is, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance.

SECTION 6. ORDINANCES REPEALED. All ordinances or parts of ordinances in conflict herewith, are hereby repealed.
