

ORDINANCE NO. 195

AN ORDINANCE PROVIDING FOR THE RESTRICTION OF ALL VEHICULAR TRAFFIC ON CERTAIN STREETS AND ALLEYS; AND PROVIDING PENALTIES FOR THE VIOLATION OF THE ORDINANCE.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING.

SECTION 1. RESTRICTION OF VEHICULAR TRAFFIC ON SPECIFIED STREETS AND ALLEYS. No person shall drive, propel, or move a motor vehicle or motor vehicles over or on any street or alley declared unsafe and closed to traffic by resolution of the Town Council when appropriate signs and/or roadblocks are placed in the street or alley designating that the street or alley is closed to vehicular traffic.

SECTION 2. SPECIFIED ALLEY CLOSED TO PARKING. That portion of the alley separating Lots 3, 4, 5 and 10' of Lot 6 and Lots 12, 13, 14 and 10' of Lot 11 between Wasatch and Midwest Streets in Block 33 of the Town of Mills is declared unsafe for any and all vehicular traffic and is closed to all vehicular traffic.

SECTION 3. ORDINANCES REPEALED. All ordinances or parts of ordinances in conflict herewith, are hereby repealed.
