

ORDINANCE NO. 207

AN ORDINANCE TO AMEND AND RE-ENACT SECTION 1 OF ORDINANCE NO. 48-C AND SECTION 7 OF ORDINANCE NO. 48 APPEARING IN THE MILLS MUNICIPAL CODE AS SECTION 5.12.070, ENTITLED "FEE" PERTAINING TO THE LICENSE FEE FOR A RETAIL LIQUOR DEALER.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING.

SECTION 1. FEE. Every person licensed as a retail liquor dealer under the provisions of the laws of the State of Wyoming and the ordinances of the Town of Mills, Wyoming, shall pay annually, in advance for a license, the maximum amount allowed to be charged under the provisions of Wyoming Statutes pertaining to alcoholic beverages, as they now exist or are hereafter amended or changed.

SECTION 2. FORMER ORDINANCE REPEALED. All existing ordinances of the Town of Mills, Wyoming, are hereby repealed insofar as they may be inconsistent with the provisions of this ordinance.


