

ORDINANCE NO. 208

AN ORDINANCE TO AMEND AND RE-ENACT SECTION 3 OF ORDINANCE NO. 161, APPEARING IN THE MILLS MUNICIPAL CODE AS SECTION 15.08.040, ENTITLED "ELECTRICAL INSPECTOR'S OFFICE CREATED" AND TO AMEND AND RE-ENACT SUB-PARAGRAPH (b) OF SECTION 10C-E OF ORDINANCE 161, APPEARING IN THE MILLS MUNICIPAL CODE AS "ELECTRICIANS' LICENSES".

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING.

SECTION 1. That Section 3 of Ordinance No. 161, 1966, be amended to read as follows:

SECTION 3. ELECTRICAL INSPECTOR'S OFFICE CREATED.

There is hereby created the office of electrical inspector. The mayor shall appoint a person of his choice to fill the office with the advice and consent of the council.

SECTION 2. That sub-paragraph (b) of Section 10C-E of Ordinance No. 161, 1966, be amended to read as follows:

SECTION 10C-E, sub-paragraph (b). Any master electrician or journeyman electrician that has a license for the City of Casper, Wyoming, County of Natrona, or issued by the State of Wyoming need not acquire any additional license to do work in the Town of Mills.

SECTION 3. FORMER ORDINANCES OR PARTS OF ORDINANCES REPEALED. Section 3 and sub-paragraph (b) of Section 10C-E, Ordinance No. 161, and any and all other ordinances or parts of ordinances in conflict herewith are hereby repealed.
