

ORDINANCE NO. 210

AN ORDINANCE TO AMEND AND RE-ENACT SECTION 4 OF ORDINANCE NO. 59, APPEARING IN THE MILLS MUNICIPAL CODE AS SECTION 9.08.030, ENTITLED "DOMESTIC ANIMALS AND POULTRY TO BE CONFINED"; TO AMEND SUCH ORDINANCE PROHIBITING THE KEEPING OF FOWL WITHIN THE TOWN LIMITS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING.

SECTION 1. That Section 4 of Ordinance No. 59, 1945, be amended to read as follows:

SECTION 4. DOMESTIC ANIMALS TO BE CONFINED AND POULTRY AND FOWL PROHIBITED WITHIN THE TOWN LIMITS. No person shall keep any duck, goose, turkey, chicken, or other domestic fowl within the town limits. Any person being the owner or possessor of any other domestic or domesticated animal shall confine the same upon his premises. Harboring any poultry or fowl within the town limits is hereby declared a nuisance and the running at large and trespassing upon the property of others of any of the aforesaid animals or poultry are hereby declared to be a public nuisance.

SECTION 2. FORMER ORDINANCE REPEALED. Section 4 of Ordinance No. 59, 1945, and any and all ordinances or parts of ordinances in conflict herewith are hereby repealed.
