ORDINANCE NO. 212

AN ORDINANCE TO AMEND AND RE-ENACT SECTION 8 OF ORDINANCE NO. 103, APPEARING IN THE MILLS MUNICIPAL CODE AS PERTAINING TO THE LOCATION AND THE AREA REQUIRED FOR BUILDINGS AND ADDING THERETO, SPACE AND LOCATION REQUIREMENTS FOR MOBILE HOMES AND TRAILERS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING.

SECTION 1. That Section 8 of Ordinance No. 103, 1951, be amended to read as follows:

SECTION 8. LOCATION AND AREA REQUIREMENTS.

No building, trailer or mobile home is to be built or set less than twenty (20) feet from the street line and not closer than ten (10) feet from the alley with the exception of a garage or accessory building. For every building, trailer or mobile home there shall be a side yard on each side of the building of not less than five (5) feet in width, provided, however, that no building, trailer or mobile home shall be erected, constructed or set nearer than ten (10) feet from any adjacent building and that for public or semi-public buildings there shall be a side yard of not less than ten (10) feet in width.

For purposes of determining which shall be the front and side setback requirements on a corner lot, any building, trailer or mobile home constructed or set on a corner lot shall be set to conform with the neighborhood.
