

ORDINANCE NO. 220

AN ORDINANCE TO AMEND AND RE-ENACT SECTION 1 OF ORDINANCE NO. 175, 1967, APPEARING IN THE MILLS MUNICIPAL CODE AS SECTION 5.12.080, ENTITLED "HOURS OF BUSINESS", PERTAINING TO THE LAWFUL HOURS OF OPERATION FOR RETAIL LIQUOR OUTLETS WITHIN THE TOWN OF MILLS, WYOMING.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING.

SECTION 1. That Section 1 of Ordinance No. 175, 1967, be amended to read as follows:

SECTION 1. HOURS OF BUSINESS: All persons licensed under this chapter shall close the dispensing room and cease the sale of both alcoholic and malt liquors promptly at the hour of two o'clock a.m. each day and keep the same closed until six o'clock a.m. the same day except that such places may open the dispensing room Sunday between the hours of twelve o'clock noon and ten o'clock p.m., and further that for a period not to exceed a total of four (4) days in any one calendar year all licensees may operate without restriction as to closing hours upon resolution and designation of such unrestricted operation by the Town Council in accordance with the provisions of Section 12-19, Wyoming Statutes, as amended, 1973.

SECTION 2. FORMER ORDINANCE REPEALED. Section 1 of Ordinance No. 175, 1967, and any and all ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 3. DECLARATION OF EMERGENCY.

WHEREAS the Forty-Second State Legislature of the State of Wyoming on the 22nd day of February, 1973, passed an Act relating

to the health, safety and welfare of the citizens of the State of Wyoming;
and,

WHEREAS the Ordinances of the Town of Mills do not comply with
the state law; and,

WHEREAS the Town Council of the Town of Mills, Wyoming,
deems it in the best interests of public health, safety and welfare that the
ordinances of the Town of Mills be uniform with the Statutes of the State
of Wyoming; therefore an emergency is hereby declared and this Ordinance
is passed as an emergency measure and the Town Council does, by the
vote by which this Ordinance is passed, hereby declare that an emergency
exists which makes it imperative that this Ordinance shall be effective
forthwith in order to preserve the public health, safety and welfare of
the citizens of the Town of Mills, Wyoming.
