ORDINANCE NO. 222

AN ORDINANCE ESTABLISHING THE MAXI-MUM PENALTIES FOR VIOLATIONS OF ANY AND ALL ORDINANCES OF THE TOWN OF MILLS, WYOMING.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING.

SECTION 1. That all ordinances providing penalties of a lesser amount than hereinafter specified are amended to read as follows:

SECTION 2. PENALTY FOR VIOLATION OF TOWN ORDINANCES.

Upon conviction by the Municipal Court of a violation of any ordinance of the Town of Mills, the Municipal Court shall have the power and authority of imposing fines not exceeding \$200.00 or imprisonment not exceeding three (3) months for each violation of a town ordinance.

SECTION 3. ORDINANCES IN CONFLICT REPEALED. Any and all ordinances or parts of ordinances in conflict herewith are hereby repealed.

## SECTION 4. DECLARATION OF EMERGENCY.

WHEREAS the Forty-Second State Legislature of the State of Wyoming on the 5th day of March, 1973, passed an Act relating to the health, safety and welfare of the citizens of the State of Wyoming; and,

WHEREAS the Ordinances of the Town of Mills do not comply with the state law; and,

WHEREAS the Town Council of the Town of Mills, Wyoming, deems it in the best interests of public health, safety and welfare that the ordinances of the Town of Mills be uniform with the Statutes of the State of Wyoming; therefore an emergency is hereby declared and this Ordinance is passed as an emergency measure and the Town Council does, by the vote by which this Ordinance is passed, hereby declare that an emergency exists which makes it imperative that this Ordinance shall

be effective forthwith in order to preserve the public health, safety and welfare of the citizens of the Town of Mills, Wyoming.
