## ORDINANCE NO. 228

AN ORDINANCE TO AMEND AND REENACT PART OF ORDINANCE NO. 185, 1969, APPEARING IN THE MILLS MUNICIPAL CODE AS SECTION 7.08.190, ENTITLED "RELEASE -- PAYMENT OF FEES" AMENDING SUCH ORDINANCE TO ESTABLISH NEW FEES FOR THE RELEASE OF ANIMALS IMPOUNDED IN THE TOWN ANIMAL POUND.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING:

SECTION 1. That part of Ordinance No. 185 appearing in the Mills Municipal Code as Section 7.08.190 pertaining to the release of impounded animals and the payment fee therefor be amended to read as follows:

RELEASE -- PAYMENT OF FEES. The person entitled to the possession of any animal impounded as provided herein, may make application to the town clerk-treasurer for the release of such animal, and upon payment of the prescribed fee, as set forth hereafter, and, in addition thereto, in the case of unlicensed dogs, the payment of the current year's license fee shall, upon presentation to the town master of the town clerk-treasurer's receipt for such fees and costs, be entitled to have such animal released to him. Provided, however, that in the event such animal is effected or is thought to be effected with rabies, hydrophobia, mange or other infectious or contagious disease or diseases, such release shall be granted only upon certification, at the owner's expense, by a licensed veterinarian that the animal is not so infected or diseased. If found to be so infected or diseased, the animal shall be destroyed.

The fees for the release of an animal are as follows:

For the first time the animal has been impounded, a fee of \$2.00 for the first day the animal has been impounded and \$1.00 for each day or any part thereof thereafter.

For the second time an animal has been impounded, a fee of \$4.00 for the first day the animal has been impounded and \$1.00 for each day or any part thereof thereafter.

For the Third time an animal has been impounded, a fee of \$8.00 for the first day the animal has been impounded and \$1.00 for each day or any part thereof thereafter.

SECTION 2. FORMER ORDINANCE REPEALED. That portion of Ordinance No. 185 appearing in the Mills Municipal Code as Section 7.08.190 and any and all other ordinances or parts of ordinances in conflict herewith are hereby repealed.
