ORDINANCE NO. 235

AN ORDINANCE PROHIBITING PARKING IN ALLEYS EXCEPT FOR LOADING AND UNLOADING AND REPEALING THOSE PORTIONS OF ORDINANCE NO. 172 IN CONFLICT THEREWITH.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN COUNCIL OF THE TOWN OF MILLS, WYOMING.

SECTION 1. That portion of Ordinance No. 172, 1967, appearing in the Mills Municipal Code as Section 10.36.070, be amended to read as follows:

SECTION 10.36.070 Parking in Alleys Prohibited. No person shall leave a vehicle parked unattended in any alley within the Town of Mills except for the purpose of actual loading and unloading in such alley.

SECTION 2. FORMER ORDINANCE REPEALED. Section 10.36.070 of the Mills Municipal Code being that portion of Ordinance No. 172, 1967, and any other ordinances or parts of ordinances in conflict herewith are hereby repealed.
