

ORDINANCE NO. 243

AN ORDINANCE TO AMEND AND RE-ENACT SECTION 7 OF ORDINANCE NO. 99, 1953, AND SECTION 1 OF ORDINANCE NO. 127, 1960, APPEARING IN THE MILLS MUNICIPAL CODE AS SECTION 13.08.060, ENTITLED HOOK-ON AND INSPECTION CHARGES.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING.

SECTION 1. That Section 1 of Ordinance No. 127, 1960, and Section 7 of Ordinance 99, 1953, be amended to read as follows:

SECTION 1. Hook-on and inspection charges.

Within the corporate limits of the town, there shall be a hook-on charge assessed for each hook-on attachment to the sewer system of the town, or to any line thereof, in the amount of Sixty (\$60.00) Dollars, together with payment to the town of the actual cost plus 10% of materials used. The charges shall be due and payable following favorable action upon any application for a sewerage service permit, the action being taken by either the council or the office of the town clerk, and prior to the issuance of the permit pursuant to favorable action, and no permit shall be granted without payment of the charges. The town treasurer shall place all monies accruing from the charges, together with all application fees collected under the provisions of Section 6, in the town treasury, in a special fund as provided hereinafter. It shall be the duty of the town treasurer to dispose and keep all monies as provided in this and other ordinances of the town. All hook-on charges and inspection fees for hook-on and in-

spections outside the corporate limits of the town shall be One Hundred Twenty (\$120.00) Dollars, together with payment to the town of the actual cost plus 10% of materials used, which monies shall be kept and disposed of in the same manner as all other charges.

SECTION 1. FORMER ORDINANCE REPEALED. Section 1 of Ordinance No. 127, 1960, and any and all ordinances or parts of ordinances in conflict herewith are hereby repealed.
