ORDINANCE NO. 256

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 127 AND SECTION 7 OF ORDINANCE NO. 99 APPEARING IN THE MILLS MUNICIPAL CODE AS 13.08.060; AMENDING SECTION 1 OF ORDINANCE NO. 191 APPEARING IN THE MILLS MUNICIPAL CODE AS 13.08.080; AND AMENDING SECTION 10 OF ORDINANCE NO. 99 APPEARING IN THE MILLS MUNICIPAL CODE AS SECTION 13.08.090 PROVIDING FOR THE COLLECTION BY THE TOWN OF A SEWER TAP INSPECTION AND INSTALLATION FEE; REQUIRING STREET CUT PERMITS; ESTABLISHING RESPONSIBILITY FOR STREET BACKFILL, COMPACTION AND REPAVING.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING.

SECTION 1. That Section 1 of Ordinance No. 127 and Section 7 of Ordinance No. 99 appearing in the Mills Municipal Code as Section 13.08.060 entitled, "Hook-on and Inspection Charges", be amended as follows:

Section 13.08.060. Fee Charged For Sewer Tap

Inspection, Backfill, Compaction and Paving.

There shall be a hook-on or tap fee charged and assessed for each hook-on or tap attachment to the sewer system of the town, or to any line thereof, in the amount of \$300.00. This fee shall include the cost to the town of providing a "tapping saddle", "Y", or a "riser" for each tap. The tap fee shall be due and payable following favorable action upon any application for a sewerage service permit, the action being taken by either the council or the office of the town clerk. No permit shall be granted without payment of the fees and charges in advance. Upon payment of all fees and charges including charges for street

cuts, the applicant shall, at the applicant's sole cost, liability and expense, make such excavation as is necessary and proper, in the sole discretion of the commissioner, from the applicant's property to the town sewer main. Prior to commencing excavation the applicant must coordinate schedules with the sewer commissioner to allow the sewer commissioner to make the sewer tap and connect the "Y", "saddle", or "riser", as is appropriate. The applicant shall be responsible to coordinate the installation of sewer lines and shall be responsible to insure that the ends of all sewer lines not immediately connected with fixtures are kept securely closed against the introduction of extraneous material as provided by Section 13.08.090, Mills Municipal Code.

In addition to the sewer tap and inspection fee, the applicant shall be required
to pay to the town clerk prior to the issuance
of a sewer permit, an additional charge computed by estimate at the rate of \$3.00 per
square foot for all paving required to be cut
in town streets to reach and properly connect
the sewer service line to the sewer main.

Upon completion of the sewer tap by the town and connection of the sewer service line to the applicant's property line by the applicant, the sewer commissioner or his authorized representatives shall thereupon backfill, compact and repave the excavation to the applicant's property line.

Notwithstanding anything herein to the contrary, the applicant shall be required to comply with all applicable ordinances of the Town of Mills as they now exist or are hereafter amended pertaining to excavation in town streets.

Notwithstanding anything herein to the contrary, the town council may establish, by written agreement, a lower fee to be paid for sewer tap and inspection in those instances where unsubdivided property is being developed or in the event of annexation into the town where the developer installs utility services at the developer's sole cost, liability and expense.

SECTION 2. That Section 1 of Ordinance No. 191 appearing in the Mills Municipal Code as Section 13.08.080 entitled, "Attachment Expense--Maintenance", be amended as follows:

Section 13.08.080. <u>Attachment Expenses; Supply of Materials; and Maintenance Responsibility.</u>

All labor and materials for each and every hook-on attachment to the main sewer line shall be furnished by the user of the installation with the exception of such "tapping saddle", "Y" or "riser" as shall be provided by and installed by the town.

Maintenance, repair and replacement of all private sewers, to include the hook-on attachment to the main line and private line to the user facility shall be the sole responsibility of the user. The town shall be responsible only for the maintenance of the main sewer lines.

SECTION 3. That Section 10 of Ordinance No. 99 appearing

in the Mills Municipal Code as Section 13.08.090 entitled, "Attachment" be amended as follows:

Section 13.08.080. Sewer Tap Restricted; Protection of Mains; Specifications.

> No tap shall be made to a main sewer line of the town by any person other than the sewer commissioner or his authorized representatives.

The applicant for sewer service shall, at all times, keep the ends of all pipes not immediately connected with fixtures securely closed against the introduction of sand, earth, water or any other material by approved water , type plugs. Suitable and proper fixtures shall be attached to all sewer service pipes as soon as possible after connection of a sewer service line to a town sewer main.

No private drain or sewer service line of any nature shall be connected with the town's sewer main otherwise than as directed by the sewer commissioner and in strict compliance with town ordinances and compliance with such specifications as shall be from time to time required by the sewer commissioner.

SECTION 4. REPEAL OF CONFLICTING ORDINANCES.

Any and all ordinances or parts of ordinances in conflict
nerewith are hereby repealed.
