AN ORDINANCE TO AMEND AND REENACT SECTION 1 OF ORDINANCE NO. 189 APPEARING IN THE MILLS MUNICIPAL CODE AS SECTION 12.04.040 ENTITLED COMPLETION AND PAYMENT OF COSTS, PERTAINING TO THE PAYMENT TO THE TOWN OF THE COSTS OF REPAIRING PAVEMENT CUTS AND INCREASING THE FEE TO BE PAID.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING.

SECTION 1. That Section 1 of Ordinance No. 189 appearing in the Mills Municipal Code as Section 12.04.040 entitled, "Completion and Payment of Costs", be amended and reenacted as follows:

Section 12.04.040. <u>Completion and Payment</u> of Costs.

All work requiring a hole, cut or fill shall be completed and filled the same calendar day to the satisfaction of the street commissioner, unless additional time is requested and approved by the street commissioner. The person, firm or corporation, property owner, utility or public utility board making any street cut shall insure that the old cut or fill be thoroughly and solidly tamped and settled.

The pavement or surfacing shall be replaced and patched by the town with material equal to the former surface at a minimum cost of \$3.00 per square foot, depending on the actual costs and expenses incurred by the town. The cost shall be paid to the town by the person, firm, corporation, property owner, utility

or public utility board responsible for making the cut.

SECTION 2. REPEAL OF CONFLICTING ORDINANCES.

Any and all ordinances or parts of ordinances in conflict herewith are hereby repealed.
