

ORDINANCE NO. 259

AN ORDINANCE TO AMEND ORDINANCE NO. 253 ENTITLED "ANNUAL APPROPRIATION BILL FOR THE FISCAL YEAR ENDING FEBRUARY 28, 1979"; AMENDING SAID ORDINANCE NO. 253 BY INCREASING THE REVENUE SHARING FUNDS REFLECTED THEREIN FROM \$25,000.00 TO \$52,000.00 AND PROVIDING FOR THE APPROPRIATION OF REVENUE SHARING FUNDS BY RESOLUTION AFTER PUBLIC HEARING.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING.

SECTION 1. The following sums of money are hereby appropriated to defray the expenses of the Town of Mills, Wyoming for the fiscal year beginning March 1, 1978 and ending February 28, 1979, to-wit:

That the revenue sharing funds reflected herein be appropriated to proper revenue sharing fund uses under the rules and regulations of the Office of Revenue Sharing, Department of the Treasury, United States Government, pursuant to public hearing and participation. That the appropriation be reflected by a Resolution adopted by the Town Council after public hearing and public participation.

SECTION 3. That Ordinance No. 253 insofar as said ordinance is inconsistent with this ordinance is hereby repealed.
