ORDINANCE NO. 263

AN ORDINANCE TO AMEND AND RE-ENACT PART OF ORDINANCE NO. 103, 1953, APPEARING IN THE MILLS MUNICIPAL CODE AS SECTION 15.04.030 ENTITLED "APPLICATION" AMENDING SUCH ORDINANCE TO EXEMPT CERTAIN MINOR REPAIRS, UPKEEP AND MAINTENANCE OF STRUCTURES WITHIN THE TOWN FROM THE PERMIT REQUIREMENTS OF SECTION 15.04.130, AND INCLUDING ANY STRUCTURAL CHANGES IN THE PERMIT REQUIREMENTS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING:

SECTION 1. That Section 15.04.030 of the Mills Municipal Code and Ordinance No. 103 of the Town of Mills is hereby amended to read as follows:

APPLICATION.

New buildings and structures hereafter erected in the town, and buildings and structures moved into or within the town shall conform to the requirements of this code. Additions, alterations, repairs, changes of use or occupancy, and structural changes in all buildings and structures shall comply with the provisions for new buildings and structures. However, minor repairs, upkeep and maintenance of structures within the town shall be excepted from the permit requirements of Section 15.04.130.
