

ORDINANCE NO. 269

AN ORDINANCE TO AMEND AND RE-ENACT PART OF ORDINANCE NO. 255, SECTION 1, 1978, AND ORDINANCE NO. 242, SECTION 2, 1976, APPEARING IN THE MILLS MUNICIPAL CODE AS SECTION 13.04.030 ENTITLED "WATER MAIN TAPS AND SERVICE LINES TO BE INSTALLED ONLY BY TOWN PERSONNEL OR AUTHORIZED REPRESENTATIVES--STREET CUTS--FEES." AMENDING SUCH ORDINANCES TO INCREASE THE FEES AND PROVIDE ADDITIONAL REQUIREMENTS FOR THE INSTALLATION OF WATER LINES.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING:

SECTION 1. That Section 13.04.030 of the Mills Municipal Code, Ordinance No. 255, Section 1, and Ordinance No. 242, Section 2 of the Town of Mills are hereby amended to read as follows:

WATER MAIN TAPS AND SERVICE LINES TO BE INSTALLED ONLY BY TOWN PERSONNEL OR AUTHORIZED REPRESENTATIVES--STREET CUTS--FEES.

(a) Any person desiring the tapping of a water main belonging to the town, for the purpose of attaching an individual line thereto, shall be required to pay to the water department office, in addition to the fee for turning the water on, as specified in Section 13.04.020, the following water tap fees:

<u>Standard Service Line</u>	<u>Domestic Use Fee</u>	<u>Commercial Use Fee</u>
3/4"	\$ 1,000.00	\$ 1,500.00

Upon payment of the fee, together with such street cut fees as are provided by ordinance or rule, the water commissioner shall, within a reasonable time thereafter, install the basic equipment for individual water service, as specified in Section 13.04.050, through the required curb box and curb cock, and including the purchase and installation

of a five-eighths inch by three-fourths inch water meter. It shall remain the responsibility of the owner to maintain the water meter.

(b) In event it is necessary to install a service line of a size greater than the standard service line, the person desiring same shall be required to pay, in advance, to the town the following fees:

<u>Standard Service Line</u>	<u>Domestic Use Fee</u>	<u>Commercial Use Fee</u>
1"	\$ 1,500.00	\$ 1,500.00
1½"	2,200.00	2,200.00
2"	2,600.00	2,600.00
3"	3,800.00	3,800.00
4"	4,600.00	4,600.00

Upon payment of the fee, together with the street cut fees as are provided by ordinance or rule, the water commissioner shall, within a reasonable time thereafter, install the basic equipment for individual water service as specified in Section 13.04.050; however, the size and type of equipment shall vary with the size of the water line, as determined by the water commissioner. All two inch lines or larger require the installation of a compound meter.

(c) Notwithstanding anything in this section to the contrary, the town council may, by written agreement, agree to a lower tap fee to be paid for water tap and inspection in those instances where unsubdivided property is being developed, or in the event of annexation into the town where the developer installs utility services at the developer's sole cost, liability and expense.

SECTION 2. FORMER ORDINANCES REPEALED. That portion of Ordinance No. 255, Section 1 and Ordinance No. 242, Section 2 appearing in the Mills Municipal Code as Section

13.04.030, and any and all other ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 3. EFFECTIVE DATE. This ordinance shall become effective October 1, 1979.

PASSED on SECOND READING the 26th day of January, 1979.

PASSED, APPROVED and ADOPTED on THIRD and FINAL READING the 11th day of July, 1979.


