

ORDINANCE NO. 278

AN ORDINANCE ADOPTING THE 1978 UNIFORM
FIRE CODE; DESIGNATING OFFICIAL COPIES;
ESTABLISHING APPEALS BOARD; PROVIDING
PENALTIES FOR VIOLATION OF THIS ORDINANCE
AND REPEALING CONFLICTING ORDINANCES.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF
MILLS, WYOMING.

SECTION 1.

ADOPTION OF CODE

Except as otherwise provided by this ordinance, all of
the 1978 Uniform Fire Code, with all appendixes, is hereby
adopted as the code governing conditions hazardous to life
and property from fire or explosion within the Town of
Mills, Wyoming, and the same are hereby adopted and incorpo-
rated as fully as if set out at length herein.

The Uniform Fire Code shall apply to all new construc-
tion and existing structures. However, owners of existing
structures shall have one (1) year from the date of passage
of this ordinance in which to comply.

SECTION 2.

OFFICIAL COPIES

The authority for adoption of this code by the town is
derived from Section 15-1-120, W.S.A. 1977, and a sufficient
number of copies, but not less than two (2) copies of the
code, shall be kept on file in the office of the town clerk
for inspection by and use of the public and shall be marked
with the words, "Town of Mills, Wyoming, Official Copy".

SECTION 3.

VIOLATIONS AND PENALTIES

Any person, firm or corporation violating any of the
provisions of this code shall be deemed guilty of a separate
offense for each and every day, or portion thereof, during
which any violation of any of the provisions of the code is
committed, continued or permitted.

SECTION 4.

APPEALS

In order to hear any appeals from and to provide for reasonable interpretations of the provisions of this code, there shall be, and is hereby created, a Board of Appeals consisting of the Town Council. The Fire Chief for the Town of Mills shall be an ex-officio member.

SECTION 5.

REPEAL OF CONFLICTING ORDINANCES

Any and all ordinances, or parts of ordinances, in conflict herewith are hereby repealed.
