

ORDINANCE NO. 286

AN ORDINANCE TO AMEND ORDINANCE NO. 103 § 6 (1953) APPEARING IN THE MILLS MUNICIPAL CODE AS § 15.04.060 BY DELETING A PORTION AND ADDING TO THE REQUIREMENTS ON AREAS REQUIRED FOR BUILDING AND OFFSTREET PARKING.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING.

SECTION 1

Ordinance 103 § 6 (1953) also appearing as 15.04.060 of the Mills Municipal Code which presently reads as follows:

15.04.060 Area: Building sites shall not be smaller than two thousand eight hundred square feet, and shall not consist of more than one residence and garage or one other out building used as living quarters.

Is amended to read as follows:

15.04.060 Area and Offstreet Parking: Building sites shall not be smaller than two thousand eight hundred square feet, and shall not consist of more than one residence and garage. Building sites shall also include a minimum of two (2) offstreet parking spaces per living unit, each space being ten (10) feet wide by twenty (20) feet long.

SECTION 2

Any and all ordinances or parts of ordinances in conflict herewith are hereby repealed.

PASSED on SECOND READING the 19 day of December, 1979.

PASSED, APPROVED and ADOPTED on THIRD and FINAL READING the 18 day of February, 1979.80
