

ORDINANCE NO. 290

AN ORDINANCE TO CREATE THE OFFENSE  
OF PUBLIC INTOXICATION: INHALATION  
OF GLUE OR TOXIC VAPORS AND  
POSSESSION FOR PURPOSES OF VIOLATION.

BE IT ORDAINED by the Governing Body of the Town  
of Mills, Wyoming:

SECTION 1. The offense of Public Intoxication; the  
Inhalation of Glue or Toxic Vapors and Possession for  
purpose of Violation shall read as follows:

A. No person shall for the purpose of causing or  
resulting in a condition of intoxication, euphoria,  
excitement, exhilaration, stupefaction, or dulling of the  
senses or nervous system, intentionally smell or inhale  
the fumes from any glue or similar toxic vapor; or consume  
or use any otherwise legal substances for a purpose  
or not in accordance with, its legitimate use or purpose  
as it is generally known, used, and advertised; provided,  
that this section shall not apply to the inhalation of  
any anesthesia for medical or dental purposes, when  
administered or directed by a licensed physician or dentist.

B. No person shall for the purpose of violating or  
aiding another in violating the provisions of this section  
intentionally possess, buy, sell, transfer possession or  
receive possession of any substances herein prohibited.
