ORDINANCE NO. 3/2

AN ORDINANCE TO ADOPT A COMPREHENSIVE ZONING PLAN, CREATE AND ESTABLISH ZONING DISTRICTS, PROVIDE FOR PROCEDURES FOR AMENDMENT AND CHANGES TO THE ZONING PLAN; CREATE A COMBINED PLANNING AND ZONING COMMISSION; AND CREATE THE POSITION OF TOWN PLANNER.

WHEREAS, the Town of Mills is in need of a more comprehensive procedure for reviewing developments within the Town, and;

WHEREAS, control over unrestricted growth by way of zoning is for the health, general welfare and the best interests of the Town, and;

WHEREAS, a Commission of interested citizens appointed by the Town Council is needed to review and provide recommendations to the Town Council on annexations, subdivisions zoning and general development in the Town, and;

WHEREAS, a Zoning Committee was formed to prepare and certify a final zoning plan to Town Council after holding public hearings as provided for by statute, and;

own public hearing on zoning and has determined that the final plan suits that best interests of the Town.

WHEREAS, a Town planner is needed to coordinate the submission of Annexation proposals, subdivision requests and zoning amendments for their review by the appropriate Town departments.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, NATRONA COUNTY, WYOMING, AS FOLLOWS: SECTION 1;

That the zoning plan attached hereto as Exhibit "A" and by this reference made a part hereof is hereby adopted as the Zoning Ordinance of the Town of Mills and shall govern the use and location of all land and structures within the Town as specified in that plan.

SECTION 2:

A. That there shall be a combined planning and zoning

- B. The Planning and Zoning Commission shall consist of five (5) members and their terms of office shall be as provided for by § 15-1-605, W.S.A., 1977 as amended.
- C. To assist the Planning and Zoning Commission, a Town planner may be appointed to coordinate the Commissions duties and act as liason between the Planning and Zoning Commission and the governing body. Town Planner shall have any additional powers as granted by the Planning and Zoning Commission or governing body.
- D. All petitions for amnexation, subdivision requests, zoning mafters and other matters authorized by State Statute or Town Ordinance to come before the Planning and Zoning Commission shall be submitted to the Planning and Zoning Commission for its review and action before being presented to the governing body for its review. The Planning and Zoning Commission shall make its recommendations to the governing body. The Planning and Zoning Commission is purely advisory and the final decisions rest with the governing body.
- E. The Planning and Zoning Commission shall adopt rules and regulations for the orderly and timely processing of the matters that come before it.

 SECTION 3:

All ordinances in conflict herewith shall be read as to give effect to the provisions of this Ordinance and if the conflicting language is such that the language cannot be read to conform then such Ordinance or part thereof is hereby repealed.
