

ORDINANCE NO. 317

ORDINANCE TO AMEND ORDINANCE NO. 141,
SECTION 1, 1963, TO PROVIDE FOR OBTAIN-
ING VARIANCE TO THE LIVESTOCK PROHIBI-
TION.

BE IT ORDAINED by the governing body of the Town of
Mills, that Ordinance 141, Section 1, 1963, appearing in the
Mills Municipal Code as § 7.04.010, entitled "Livestock
Prohibited", Which presently reads:

"It is unlawful for any person or persons,
corporations or associations to keep and
maintain, within the corporate limits of
the Town, any horses, cows, mules, burros,
donkeys, sheep, goats, pigs, hogs, or swine;
provided, however, the Marshal of the Town
may give permission to keep saddle horses
in the Town for not more than twenty-four
(24) hours."

is amended to read as follows:

"It is unlawful for any person or persons,
corporations or associations to keep and
maintain, within the corporate limits of
the Town, any horses, cows, mules, burros,
donkeys, sheep, goats, pigs, hogs or swine;
provided, however, upon petition to the
governing body of the Town of Mills a
variance from the provisions of this
Ordinance may be obtained upon the terms
and conditions required by the governing
body of the Town of Mills; and provided,
however, the Marshal of the Town, may give
permission to keep saddle horses in the
Town for not more than twenty-four (24)
hours."
