

ORDINANCE NO. 327

AN ORDINANCE TO AMEND AND RE-ENACT A PORTION OF ORDINANCE NO. 130, SECTION 60(a), 1962, APPEARING IN THE MILLS MUNICIPAL CODE AS 10.44.040 TO INCREASE THE WEIGHT LIMIT FOR TRUCKS IN THE TOWN OF MILLS.

WHEREAS, the Town Council of the Town of Mills has determined that the weight limits presently in effect for the Town of Mills are far to low for the existing uses within the Town, including that of motor homes and semi-truck tractors.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, as follows:

SECTION 1:

That that portion of Ordinance No. 130, Section 60(a), 1962, appearing in the Mills Municipal Code as 10.44.040, entitled Operation of Trucks, which presently reads:

"It shall be unlawful to drive or operate any truck which weight, together with its load, is in excess of 8,000 pounds upon the streets of the Town other than upon designated through streets, except when the truck is engaged in either making a pick up or delivery to a point within the Town. In such instances the truck shall proceed to the place of the pick up or delivery by the shortest possible route and return to the through streets by the shortest possible route."

and should be amended to read as follows:

"It shall be unlawful to drive or operate any truck which weight, together with its load, is in excess of 16,000 pounds upon the streets of the Town other than upon designated through streets, except when the truck is engaged in either making a pick up or delivery to a point within the Town. In such instances the truck shall proceed to the place of the pick up or delivery by the shortest possible route and return to the through streets by the shortest possible route."

SECTION 2:

All ordinances in conflict herewith are hereby repealed.
