

ORDINANCE NO. 336

AN ORDINANCE TO AMEND AND RE-ENACT ORDINANCE NO. 238, SECTION 1, 1976, APPEARING IN THE MILLS MUNICIPAL CODE AS SECTION 2.16.010, TO INCREASE THE MAYOR'S SALARY FROM \$200.00 EACH MONTH TO \$400.00 EACH MONTH.

WHEREAS, the Mayor expends considerable time away from his occupation in order to pursue the duties of Mayor; and,

WHEREAS, the Mayor's salary has not been increased since 1976; and,

WHEREAS, the Wyoming State Legislature has authorized the city and towns to increase Mayor's salary to a maximum of \$4,800.00 per year.

IT IS HEREBY ORDAINED by the governing body of the Town of Mills:

1. That the Mayor's salary shall be paid at the rate of \$400.00 each month.

PASSED on FIRST READING the 3 day of February, 1982.

PASSED on SECOND READING the 10 day of February, 1982.

PASSED, APPROVED and ADOPTED on THIRD and FINAL READING the 24 day of February, 1982.
