

ORDINANCE NO. 344

AN ORDINANCE PROHIBITING ENTRY TO PRIVATE PROPERTY, DEFINING UNLAWFUL ENTRY, DEFINING THE PROPERTY PROTECTED BY THIS ORDINANCE, DECLARING UNLAWFUL ENTRY TO BE A MISDEMEANOR, AND ESTABLISHING A PENALTY FOR VIOLATION.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, NATRONA COUNTY, WYOMING, AS FOLLOWS:

Section 1. It is unlawful for any person to enter into, on or upon the private property of another in the Town of Mills without the consent or permission of the owner or person lawfully in possession thereof or unless otherwise authorized by law for such entry..

Section 2. The property or premises of another shall be deemed to include, without limitation, the home, enclosed yard, garages, outbuildings, motor vehicles, mobile homes, trailers, travel trailers, or apartment lawfully in the possession of another, and shall further be deemed to include business premises or business buildings of another at all times when such business premises or buildings are closed to the general public.

Section 3. Any person who violates the provisions of this ordinance shall be deemed guilty of a misdemeanor and shall be subject to a fine not to exceed Two Hundred (\$200.00) Dollars.
