

ORDINANCE NO. 373

AN ORDINANCE TO AMEND AND RE-ENACT PART OF ORDINANCE NO. 267, SECTION 1, 1979, APPEARING IN THE MILLS MUNICIPAL CODE AS SECTION 13.08.160 ENTITLED "CHARGES FOR SEWER SERVICE".

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING.

SECTION 1. That Section 13.01.160 of the Mills Municipal Code and Ordinance No. 267, Section 1, of the Town of Mills is hereby amended to read as follows:

EFFECTIVE January 1, 1986, the following shall be:

CHARGES FOR SEWER SERVICE.

(a) Charges for sewer service for one family units being served by an individual sewer hookup shall be eighteen dollars (18.00) per quarter.

(b) Charges for sewer service for more than one family unit shall be twenty-four dollars (24.00) per quarter year plus a gallonage charge if applicable. The minimum charge is based upon usage of nine thousand gallons of water per quarter year. Each of the multiple users that use in excess of nine thousand gallons of water per quarter year shall be charged the minimum charge plus twenty cents (.20) for each additional one thousand gallons used in excess of nine thousand gallons per quarter year. The sewerage charge for the second, third and fourth quarter of each year, (April 1st through December 31st) shall be the same as billed for the first quarter year. Users that were not billed during the first quarter year shall pay the charge set out above. Charges for domestic sewerage service outside the corporate limits of the town, shall be in the sum of twenty-seven dollars (27.00) per quarter year, the charge to be the minimum charge and based upon the use of nine thousand gallons of water per quarter year. Each user that uses in excess of nine thousand gallons per quarter year shall be charged the minimum charge, plus thirty cents (.30) for

each one thousand gallons used in excess of the nine thousand gallons for each quarter year.

(c) Charges for sewer service within the corporate limits of the town for trailer courts having ten or more trailers shall be charged upon the rate set out above in paragraph (b), except that the charges shall be computed on water actually used each quarter year.

(d) The charges for sewerage service for commercial establishments within the corporate limits of the town shall be computed on the rates set out in paragraph (b) above, but the charges will be computed on water actually used each quarter year.

SECTION 2. EFFECTIVE July 1, 1986, the following shall be:

CHARGES FOR SEWER SERVICE.

(a) Charges for sewer service for one family units being served by an individual sewer hookup shall be twenty-seven dollars (27.00) per quarter.

(b) Charges for sewer service for more than one family unit shall be thirty-six dollars (36.00) per quarter year, plus a gallonage charge if applicable. The minimum charge is based upon usage of nine thousand gallons of water per quarter year. Each of the multiple users that use in excess of nine thousand gallons of water per quarter year shall be charged the minimum charge plus thirty cents (.30) for each additional one thousand gallons used in excess of each nine thousand gallons per quarter year. The sewerage charge for the second, third and fourth quarter of each year, (April 1st through December 31st) shall be the same as billed for the first quarter year. Users that were not billed during the first quarter year shall pay the charge set out above. Charges for domestic sewerage service outside the corporate limits of the town, shall be one and one-half ($1\frac{1}{2}$) times the amount charged for inside the corporate limits, the charge to be the minimum charge and based upon the use of nine thousand gallons per quarter year. Each user that uses in excess of nine thousand gallons per quarter year shall be charged the minimum charge, plus

forty-five cents (.45) for each one thousand gallons used in excess of the nine thousand gallons for each quarter year.

(c) Charges for sewer service within the corporate limits of the town for trailer courts having ten or more trailers shall be charged upon the rate set out above in paragraph (b), except that the charges shall be computed on water actually used each quarter year.

(d) The charges for sewerage service for commercial establishments within the corporate limits of the town shall be computed on the rates set out in paragraph (b) above, but the charges will be computed on water actually used each quarter year.

SECTION 3. FORMER ORDINANCE REPEALED. That portion of Ordinance No. 267, Section 1, appearing in the Mills Municipal Code as Section 13.08.160 and any and all other ordinances or parts of ordinances in conflict herewith are hereby repealed.




