

ORDINANCE NO. 384

AN ORDINANCE AMENDING ORDINANCE NO. 230, SECTION 10, 1974, APPEARING IN THE MILLS MUNICIPAL CODE AS 6.04.190 ENTITLED, COLLECTION--FEES.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING,

SECTION 1. That Section 6.04.190 of the Mills Municipal Code is hereby amended to read as follows:

6.04.190 Collection Fees. (1) Each residence or business located within the town shall be charged a minimum of \$4.50 per month for the availability of garbage and waste matter collection and disposal and the Town shall, without further charge, collect and dispose a reasonable quantity of garbage and waste matter from each residence or business. In this connection, a reasonable amount shall not exceed the equivalent of two 55 gallon barrels of garbage collected once each week.

(2) For collections more often than once each week, or in excess of the equivalent of two 55 gallon barrels, the town shall make the following additional charges:

A. For each pickup of the equivalent of two 55 gallon barrels, additional to once each week, \$4.50.

B. For each additional barrel, or equivalent, per pickup, \$2.25.

C. For each three (3) yard bin picked up once each week the charge shall be \$12.00, picked up twice each week \$24.00, picked up three times a week \$36.00, picked up four times each week \$48.00, picked up 5 times each week \$60.00.

D. In the event an extra haul is requested, the charge shall be \$5.00 for residential and \$7.50 for businesses.

(3) Whenever it is impossible to determine the fees to be charged by virtue of the fact that the garbage or waste matter to be collected is not stored in and cannot be calculated in the equivalent of fifty-five gallon barrels, the Mayor or the Mayor's representative shall, over a period of not less than one week, study and determine the amount of garbage and waste matter to be collected from the premises and based upon the time involved, the nature of the garbage and waste matter and the volume of the garbage and waste matter shall determine a reasonable fee

to be charged for the collection services.

SECTION 2. Effective date for these charges shall be May 1, 1988.

SECTION 3. That portion of Ordinance No. 230, Section 10, 1974, appearing in the Mills Municipal code as 6.04.190 and any and all other ordinances or parts of ordinances in conflict herewith are hereby repealed.
