## ORDINANCE NO. 390

AN ORDINANCE TO AMEND PART OF ORDINANCES 349 AND 276 APPEARING IN THE MILLS MUNICIPAL CODE AS SECTION 5.12.070(e) AND 5.12.210, REDUCING THE ANNUAL FEES FOR RETAIL AND RESTAURANT LIQUOR LICENSE

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING:

Section 1. That part of Ordinance 349 appearing in the Mills Municipal Code as Section 5.12.070(e) is hereby amended to read as follows:

The annual fee assessed for a retail liquor license shall be One Thousand Two Hundred and No/100 Dollars (1,200.00) payable annually in advance of original issue and each renewal.

Section 2. That part of Ordinance 276 appearing in the Mills Municipal Code as Section 5.12.210 is hereby amended to read as follows:

The annual fee assessed for a restaurant liquor license shall be One Thousand Two Hundred and No/100 Dollars (\$1,200.00) payable annually in advance of original issue and each renewal.

This ordinance shall be in full force and Section 3. effect ten (10) days following its passage and approval on final reading and posting as required by law.
